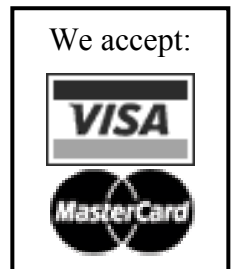
Type of Interpreting Setting-Two Hour Minimum Per Assignment	FEE
Regular (non-medical, non-legal, non-social service agency situations)	\$38.00 per hour
Social Services (SSA, DCF, agencies) or Medical (doctor, dentist, physical therapy, x-ray, etc.)	\$48.00 per hour
Medical In-Depth (mental health, surgery, pre-op meetings)	\$53.00 per hour
Legal (initial consult, attorney/client meeting, signing legal docs, court ordered meetings/classes)	\$58.00 per hour
Legal In-Depth (trials, depositions, interrogations)	\$63.00 per hour

#### Additional fees:

- Evenings (after 5pm/before 8am), weekends and holidays - \$5.00/hour
- Mileage (.325 per mile) - outside Duval County
- Transit (\$35/hour) - Volusia or Flagler counties, or out of state travel time
- Less than 3 business days advance notice - \$3.00/hour
- Less than 24 hours notice, additional \$10.00 charge.
- Parking/Lunch (during luncheons)

#### Scheduling Policies

- Please contact the ILRC at least 3 business days in advance.
- When interpreter services are needed for more than 2 hours, 2 interpreters are required.
- ILRC will bill in full for "no shows" or assignments cancelled in less than 2 business days.
- If either party does not show up, interpreters are only required to stay 15 minutes per hour scheduled.
